The U.S. Department of Agriculture (USDA) invites offers to sell shell eggs pursuant to the AMS Master Solicitation for use in the Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, November 23, 2015. Deliveries are to be made between January 1, 2016 and March 31, 2016.

This Solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of three. However, a price is required on all line items within the lot.
