The U.S. Department of Agriculture (USDA) invites offers to sell Canned Vegetables pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, August 12, 2016. Deliveries are to be made between October 1, 2016 and December 31, 2016.

Offerors who intend to use more than one processing plant and shipping point for contracts awarded under this solicitation, other than the processing plant and shipping point entered in their bids, may submit a list of their approved processing plants and shipping points on a separate sheet of paper to be uploaded in WBSCM, and to be submitted with their bids.

TOMATO SAUCE CAN 6/10 (100334) is 50% Small business Set-Aside. NAICS Code 311421 with a business size of 500 employees or less applies to this requirement.

TOMATO PASTE CAN 6/10 (100327) and TOMATO SAUCE CAN 6/10 (100334) are 10% Service Disabled Veteran Owned Small Business Set-Aside.


