a. Question: I noticed on the specs for frozen carrots that it has both sliced and diced. I do not see a distinction on this bid for carrots. We can do diced but not sliced. Can you verify whether the bid 2000005289 is sliced or diced carrots?

Answer: Solicitation 2000005289 is for <u>Sliced</u> Frozen Carrots Ctn-30LB (Material 100352). See Exhibit 3 on page 16 of the Commodity Specification for Frozen Vegetables, dated April 2018.

b. Question: Is Solicitation 2000005322 some sort of supplemental bid to solicitation 2000005289? Are any of the #10 packs small business set-asides?

Answer: No, solicitation 2000005322 is not a supplemental bid. Solicitation 2000005322 is for Carrots Can-24/300 (Material 100308) only. There is a 15% small business set-aside for material 100308.
