The U.S. Department of Agriculture (USDA) invites offers to sell CANNED FRUIT pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight April 30th, 2019. For material 100216, deliveries are to be made between October 1, 2019, and September 30, 2020. For materials 100210, 100211, 100212, 100223, 100224, 100225, and 100226 deliveries are to be made between October 1, 2019, and December 31, 2019.

Canned products will be accepted for up to 18 months from the date of inspection.
