The U.S. Department of Agriculture (USDA) invites offers to sell Dried Fruit Raisins pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs.

This invitation for bids is part of the Food Purchase and Distribution Program under the authority of the Commodity Credit Corporation (CCC), with the purpose to assist farmers in response to trade damage from unjustified retaliation. Funding for this purchase is under Section 5 of the CCC Charter Act.

Offerors who place a bid on this solicitation are agreeing to ALL terms and conditions outlined in the MSCP, specifications, and other attached documents. Late bids will NOT be accepted. Modifications of bids after bid opening date will NOT be accepted. Failure to adhere to contract terms and conditions may result in Termination for Default.

Acceptances will be announced by midnight, Friday May 31, 2019. Deliveries are to be made between July 16, 2019 and September 30, 2019.

In accordance with Federal Acquisition Regulation (FAR) 52.203-2 (as found in SAM.gov representations and certifications) offerors have certified that the prices in their offer have been arrived at independently, without, for the purpose of restricting competition, any consultation, communication, or agreement with any other offeror or competitor. In accordance with procedures outlined in FAR 3.301, suspicion of collusive activities shall result in a rejection of the offeror(s) by the contracting officer. As such, contracting personnel are an important potential source of investigative leads for antitrust enforcement; USDA/AMS is required by 41 U.S.C. 3707 and 10 U.S.C. 2305(b)(9) to report any bids or proposals that evidence a violation of the antitrust laws.

The requirements for Checkloading by USDA inspectors outlined in the attached Commodity Specifications are NOT applicable to contracts awarded under this solicitation. Note: Checkloading may still be performed by USDA Inspections Staff as outlined in the commodity specifications, at the expense of the contractor, however it is not required for contracts awarded under this solicitation.


