The U.S. Department of Agriculture (USDA) invites offers to sell shell eggs pursuant to the AMS Master Solicitation for use in the Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, August 9, 2019. Deliveries are to be made between October 1, 2019 and December 31, 2019.

This Solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of three. However, a price is required on all line items within the lot.
