The U.S. Department of Agriculture (USDA) invites offers to sell fortified ready-to-eat cereal pursuant to the AMS Master Solicitation for use in Federal Food and Nutrition Assistance Programs. Bids are due by 1pm CT on July 29, 2019. Acceptances will be announced by 5pm CT, on August 1, 2019. Deliveries are to be made between October 1, 2019 through December 31, 2019.


