The U.S. Department of Agriculture (USDA) invites offers to sell whole eggs pursuant to the AMS Master Solicitation for use in the Federal food and nutrition assistance programs. Acceptances will be announced by midnight, November 20, 2019. Deliveries are to be made between January 1, 2020 and January 31, 2020.

This Solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of three. To determine the number of destinations, review the "Tendering Text" for the lot, which will indicate the City and State for each stop. Bidders may submit different prices for each stop. However, a price is required on all line items within the lot.

This solicitation is 100% Total Small Business Set Aside for material 100046, EGGS WHOLE FRZ CTN-6/5 LB. and 100047, EGGS WHOLE LIQ BULK -TANK. See FAR 52.219-6 Notice of Total Small Business Set Aside. NAICS Code 311999 with size standard of 500 employees and below applies to this solicitation.
