This invitation for bids is part of the Food Purchase and Distribution Program under the authority of the Commodity Credit Corporation (CCC), with the purpose to assist farmers in response to trade damage from unjustified retaliation. Funding for this purchase is under Section 5 of the CCC Charter Act. Acceptances will be announced by midnight, December 4, 2019. Deliveries are to be made between January 1, 2020 and March 31, 2020.

Bid items with a delivery period of 1/1/2020 -1/15/2020 will be extended to 1/20/2020 - 2/4/2020 due to the late issuance of this Solicitation.
