The U.S. Department of Agriculture (USDA) invites offers to sell Bottled Juice pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, December 4, 2019. Deliveries are to be made between January 1, 2020 and March 31, 2020.

This is a re-solicitation of the cancelled invitation 2000006490.

Bid items with a delivery period of 1/1/2020 -1/15/2020 will be extended to 1/20/2020 - 2/4/2020 due to the late issuance of this Solicitation.

Apple Juice (100893), Cherry Apple Juice (100894), Grape Concord Juice (100895), and Cranberry Apple Juice (100899) are (100%) Small Business Set-Aside. NAICS Code 311421 with a business size of 1000 employees or less applies to this requirement.

Orange Juice (100897) is 65% Small Business Set-Aside. NAICS Code 311421 with a business size of 1000 employees or less applies to this requirement.

Grape Concord Juice (100895) is (10%) Service Disabled Veteran Owned Small Business Set-Aside.


