The U.S. Department of Agriculture (USDA) invites offers to sell Bottled Juice pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, February 13, 2020. Deliveries are to be made between April 1, 2020 and June 30, 2020.

Apple Juice (100893), Cherry Apple Juice (100894), Grape Concord Juice (100895), and Cranberry Apple Juice (100899) are (100%) Small Business Set-Aside. NAICS Code 311421 with a business size of 1000 employees or less applies to this requirement.

Orange Juice (100897) is 65% Small Business Set-Aside. NAICS Code 311421 with a business size of 1000 employees or less applies to this requirement.

Grape Concord Juice (100895) is (10%) Service Disabled Veteran Owned Small Business Set-Aside.
