The U.S. Department of Agriculture (USDA) invites offers to sell Frozen Fruit Juice pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, February 13, 2020. Deliveries are to be made between April 1, 2020 and June 30, 2020.
