This invitation for bids is part of the Food Purchase and Distribution Program under the authority of the Commodity Credit Corporation (CCC), with the purpose to assist farmers in response to trade damage from unjustified retaliation. Funding for this purchase is under Section 5 of the CCC Charter Act. Acceptances will be announced by midnight, August 14, 2020. Deliveries are to be made between October 1, 2020 and December 31, 2020.
