The U.S. Department of Agriculture (USDA) invites offers to sell Bottled Juice pursuant to Section 32, and the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, Monday, March 15, 2021. Deliveries are to be made between May 1, 2021 and September 30, 2021.

Crop Year: 2019/2020 will be accepted.

Purchases will be made on an f.o.b. destination basis to cities on this Solicitation. Destination quantities listed are estimates and subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.
