The U.S. Department of Agriculture (USDA) invites offers to sell SHELL EGGS pursuant to the AMS Master Solicitation for use in the Federal food and nutrition assistance programs. This solicitation is issued under the authority of Section 32. Acceptances will be announced by midnight, March 24, 2021. Deliveries are to be made April 1, 2021 and September 30, 2021.

This Solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of eight. To determine the number of destinations, review the "Tendering Text" for the lot, which will indicate the City and State for each stop. Bidders may submit different prices for each stop. However, a price is required on all line items within the lot.

The solicitation is issued purchasing a less than truckload (LTL) quantity.

This Solicitation includes the following changes to the FPPS for Shell Eggs dated April 2017 (Item 100936):

352 A delivery unit shall consist of a solicitation line item. Each unit shall consist of only one size or color of eggs in one type of packaging and packing material, with only one format of labeling. Mixing egg sizes, colors, packaging and packing materials and labeling format are not permitted in a delivery unit.

352.1 For multi-stop deliveries, where the quantity is less than 1,500 cases, the contractor shall maintain a segregation plan for loading and deliveries.

\*\* Please note, constraints are to be entered in pounds verses TRK unit of measure.
