The U.S. Department of Agriculture (USDA) invites offers to sell frozen pork products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, February 17, 2022. Deliveries are to be made between April 1, 2022 - June 30, 2022..

The pork products are to be delivered fresh chilled or frozen as indicated by product type.

This solicitation is a one hundred percent (100%) Small Business Set Aside for Material 110380 (Pork Chops) - see FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611 Business size 1000 employees or less apply to this requirement.

This Solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of three. However, a price is required on all line items within the lot.
