Checkloading: The requirements for checkloading by USDA inspectors outlined in the Commodity Specifications for canned and frozen fruit are NOT applicable to contracts awarded under this solicitation.

Acceptable pack years include: For products delivering in calendar year 2022, product produced in calendar year 2021 and 2022 will be accepted.
