A01 - The purpose of this amendment is to extend the Offer Due Date to 03/01/2022 at 13:00 CST and Award date to 03/07/2022, due to an administrative error in posting to Govdelivery.

The U.S. Department of Agriculture (USDA) invites offers to sell frozen beef products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal food and nutrition assistance programs. Acceptances will be announced no later than midnight, February 28, 2022.

Deliveries are to be from April 01, 2022 to April 30, 2022.

All line items identified as Coarse Ground Beef for Further Processing into Fully Cooked Items - Type 1, which will determine the level of microbial testing required. Please review Sections 320.8.1 and 321.6 for Type 1 of Supplement 211, dated August 2017 for more information.

All line items identified as Coarse Ground Beef - Type 2, which determines the level of microbial testing required. Please review Sections 320.9 and 321.7 for Type 2, of Supplement 211, dated August 2017 for more information.

This Solicitation is a thirty (30%) Small Business Set-Aside - See FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611- Business size 1,000 employees or less apply to this requirement.

This Solicitation is a ten percent (10%) Service Disabled Veteran-Owned Small Business (SDVOSB) Set-Aside.

The Solicitation may show multiple stops on some line items, however, the number of stops will be limited to a maximum of three. To determine the number of destinations review the "Tendering Text" for the lot, which will indicate the City and State for each stop. Bidders may submit different prices for each stop. However, a price is required on all line items within the lot.

Offerors who intend to use more than one processing plant and shipping point for contracts awarded under this solicitation, other than the processing plant and shipping point entered in their bids, may submit a list of their approved processing plants and shipping points on a separate sheet of paper to be uploaded in WBSCM, and to be submitted with their bids.

For offshore destinations (Puerto Rico, Hawaii, etc.), offerors have the option to choose to enter their bids direct to the offshore destination or to the port.

Purchases will be made on an f.o.b. destination basis to cities on this Solicitation. Destination quantities listed are estimates and subject to adjustment based on offerings, changes in recipient needs,
