**Orange Juice**

**1. Grade – U.S. Grade A as cited in the U.S. Standards for Grades of Canned Orange Juice - Canned orange juice from concentrate.**

**Bottled orange juice from concentrate must be U.S. Grade A for all factors and requirements except for:**

- **Requires a minimum color equal to or better than USDA OJ 6.**
- **A minimum Brix-Acid Ratio of 13.5 to 1, a maximum Brix-Acid Ratio of 20.5 to 1.**
- **A minimum Brix of 11.8 degrees.**
- **Flavor evaluation score must be no lower than 35 score points in accordance with the U.S. Standards for Grades of Canned Orange Juice.**
- **Recoverable oil – Maximum 0.035 percent by volume.**
