The U.S. Department of Agriculture (USDA) invites offers to sell Pork Products pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due by 1pm CT on September 18, 2023. Acceptances will be announced by 5pm CT on September 25, 2023. Deliveries are to be made between November 1, 2023, and November 30, 2023.
