

PURCHASE AWARD DESCRIPTION

The Department of Agriculture (USDA) purchased Fresh Vegetables as indicated below for distribution to the National School Lunch Program and other Federal Food and Nutrition Assistance Programs for Fiscal Year 2024.

The purchase is the result of offers received in response to Solicitation No. 2000009713 dated November 17, 2023.

The materials were purchased on an f.o.b. destination basis. Deliveries are to be made from January 10, 2024 through June 26, 2024.

Shortfalls-

There was a shortfall of 1,600 cases (2 trucks), due to vendor constraints.
