The U.S. Department of Agriculture (USDA) invites offers to sell FROZEN FRUIT pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, May 9, 2024. Deliveries are to be made between July 1, 2024 through September 30, 2024.

Note-Checkloading may still be performed on all, or part of the deliveries at the request and expense of the contractor; however, it is not required for Frozen Fruit awarded under this solicitation. Also, SCI will conduct periodic verifications of the vendors commercial practices to ensure they meet the contractual requirements.

2023 and 2024 is an acceptable crop year for these products.
