The Department of Agriculture (USDA) purchased Fresh Peaches, Nectarines, and Plums as indicated below for distribution to the National School Lunch Program (NSLP) and other Federal Food and Nutrition Assistance Programs for Fiscal Year 2024 as part of the Section 32 purchases.

The purchase is the result of offers received in response to Solicitation No. 2000010080 dated April 29, 2024. The materials were purchase on a f.o.b destination basis. Deliveries are to be made between June 16, 2024, and January 31, 2025.

There was a short fall of 15 trucks for Fresh Nectarines based on vendor available quantity constraints for the delivery period.
