The U.S. Department of Agriculture (USDA) invites offers to sell Canned Fruit pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, May 17, 2024. Deliveries are to be made between July 16, 2024 and October 31, 2024.

***** Offerors must submit a unit price in WBSCM, for delivery to EACH STATE, inclusive of all costs associated through final delivery. A price is required for every state and all state prices must be determined fair and reasonable for a bid to be determined responsible. *****

There is a probationary period for new-to-AMS contractors and existing contractors bidding on new products in which awards are limited to 10 truckloads per product. Contractor must demonstrate successful delivery of at least five (5) truckloads of [new] product in order to be removed from probationary status on future solicitations. For the purposes of this rule, successful delivery is defined as product delivered on-time and in acceptable condition according to the terms and conditions of the contract.
