The U.S. Department of Agriculture (USDA) invites offers to sell Frozen Beef Products pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due by 01:00 pm CT on May 21, 2024. Acceptances will be announced by 11:59 pm CT on May 30, 2024.

Deliveries are to be made between July 01, 2024 through July 31, 2024.

All line items for this solicitation identified as Coarse Ground Beef Type 1, which will determine the level of microbial testing required. Please review Sections 320.8.1 and 321.6 for Type 1 of Supplement 211, dated March 2023 for more information.

This Solicitation is a thirty (30%) Small Business Set-Aside - See FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611- Business size 1,150 employees or less apply to this requirement.

This Solicitation is a ten percent (10%) Service Disabled Veteran-Owned Small Business (SDVOSB) Set-Aside.

Domestic Origin # All meat shall originate from livestock that are born, raised, and harvested in the United States, its territories or possessions (U.S.) If the establishment receives and processes livestock from outside the U.S., a segregation plan shall be put in place to preclude non-conforming product from being introduced into Federal nutrition assistance programs.

* * For a new -to-USDA contractor and existing contractors bidding on new products, a probationary period will be implemented in which awards are limited to 10 truckloads per product. Contractor must demonstrate successful delivery of at least five (5) truckloads of product to be removed from probationary status on future solicitations. For the purposes of this rule, successful delivery is defined as product delivered on-time and in acceptable condition according to the terms and conditions of the contract. Any delivery problems directly attributable to the Government will not be held against the contractor.* *
