The U.S. Department of Agriculture (USDA) invites offers to sell WHOLE EGGS AND EGG PATTIES pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due on November 5, 2024. Acceptances will be announced by 11:59 pm CT on November 19, 2024. Deliveries are to be made between January 1, 2025 through March 31, 2025.
