The U.S. Department of Agriculture (USDA) invites offers to sell Canned Fruit pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, November 12, 2024. Deliveries are to be made between January 1, 2025 and March 31, 2025.


