The Dairy Business Innovation Alliance (DBIA), a partnership between the Center for Dairy Research at the University of Wisconsin-Madison and the Wisconsin Cheese Makers Association (WCMA), is seeking grant proposals from organic dairy processors. Funded by USDA's Organic Dairy Production Promotion Program, DBIA will distribute \$3.75 million in grant awards ranging from \$100,000 to \$1.5 million to processors to support costs associated with the distribution of organic dairy products for students and young adults (ages 0-25) in institutional settings such as schools, colleges, and youth organizations. Proposal submissions are due by 5 pm CT on February 21, 2025.
