The Dehydrated Potatoes were purchased on an f.o.b. destination basis. Deliveries are to be made from September 1, 2016 through December 31, 2016.

A total of 7,500 cases of POTATOES DEHYDRATED FLKS PKG-12/1 LB were not awarded due to funding constraints.
