The U.S. Department of Agriculture (USDA) invites offers to sell frozen beef products pursuant to the AMS Master

Solicitation for use in the domestic food distribution programs. Bids are due by 1pm CT on June 20, 2023.

Acceptances will be announced by 5pm CT on June 27, 2023. Deliveries are to be made between August 1, 2023, and August 31, 2023.

This Solicitation identifies line items that are Coarse Ground Beef for Further Processing into Fully Cooked Items:

This Solicitation is a thirty (30%) Small Business Set-Aside - See FAR 52.219-6 Notice of Small Business Set-Aside. NAICS Code 311611- Business size 1,000 employees or less apply to this requirement.

This Solicitation is a ten percent (10%) Service Disabled Veteran-Owned Small Business (SDVOSB) Set-Aside.
