The U.S. Department of Agriculture (USDA) invites offers to sell Chicken and Chicken products (BULK) pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due by 1:00 pm CT on August 01, 2024. Acceptances will be announced by 11:59 pm CT on August 15, 2024. Deliveries are to be made between September 01, 2024 and October 31, 2024.

Contractor must demonstrate successful delivery of at least five (5) truckloads of product to be removed from probationary status on future solicitations. For the purposes of this rule, successful delivery is defined as product delivered on-time and in acceptable condition according to the terms and conditions of the contract.
