Effective October 1, 2023

FGIS Administrative Tonnage Fees. In addition to all other applicable fees, FGIS administrative tonnage fees for export grain shipments inspected and/or weighed, excluding land carrier shipments to Canada and Mexico, will be assessed at the current per metric ton rate identified in FGIS Directive 9180.74 Service Fees and Billing Codes, Attachment 1. Invoices will identify assessed administrative tonnage fees as separate line items per applicable carrier/unit type.

FGIS Supervision Fees. In addition to all other applicable fees, FGIS supervision fees for domestic U.S. grain shipments inspected and/or weighed, including land carrier shipments to Canada and Mexico, will be assessed at the current per metric ton rate identified in FGIS Directive 9180.74 Service Fees and Billing Codes, Attachment 2. Invoices will identify assessed supervision fees as separate line items per applicable carrier/unit type.

ESTABLISHED INSPECTION POINTS: Mobile

REGULAR HOURS:

\$42.00 per hour per person

7:00 a.m. to 5:00 p.m. Monday through Friday, except holidays and when a shift is scheduled in advance (excluding Saturday and Sunday) by an applicant for truck, railcar, and barge inspection and weighing. Regular hours 7:00 AM. to 5:00 P.M. Monday through Friday subject to meeting elevator requirement, not to exceed 8 hours per day. The \$42.00 hourly rate per person will apply in addition to all unit fees (unless noted) and any services not identified by a unit fee.

OVERTIME: **\$52.50 Per Individual Hour**

A four-hour minimum per individual when called out on overtime EXCEPT; One hour before or continuation of a regular workday.

HOLIDAY:

Holidays include New Years' Day, Veterans' Day, July 4th, Labor Day, Thanksgiving Day, Christmas Day, National Memorial Day, Mardi Gras, Confederate Memorial Day, Martin Luther King's birthday, Columbus Day, Jefferson Davis's birthday, and George Washington's birthday, and those granted by the Governor of Alabama.

Cancellation of Shift Work - \$42.00 per each man hour if not cancelled during workday prior to schedule.

Charges are assessed in half-hour increments in addition to carrier and sample fee.



TRAVEL TIME CHARGE: \$42.00 Per Individual Hour

MILEAGE CHARGE: "The IRS standard mileage rate will be assessed per actual miles traveled plus travel time. Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Mileage and travel time will be prorated when it is possible."

OFFICIAL SERVICES: Official Services not covered in this schedule will be charged at the appropriate hourly rate.

STANDBY TIME

A four-hour minimum per person will apply for any work after 11:00 p.m. any day of the week. A minimum of 4 hours at regular or overtime rate when applicable will be applied when personnel are cancelled from an established shift.
