Effective Date: January 1st, 2025. This fee schedule supersedes all other fees schedules issued by this office. The Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies will assess only those fees appearing on their currently approved fee schedule.

Regular Hours

Office Hours: 6:00 AM to 2:00 PM – Monday thru Friday

Inspection Hours: 5:00 AM to 2:00 PM – Monday thru Friday. If you would like same day inspection, please notify us by 9:00 AM. For weekend or holiday inspection service, please notify us by 12:00pm of the previous business day.

Sampling Hours: 8:00 AM to 5:00 PM – Monday thru Friday. For same day sampling, please notify us by 11:00 AM.

Overtime Hours: Hours beyond regular hours – Monday thru Friday and all day Saturday.

Double Time: Will be charged for Sundays and Holidays.

Holidays Include: New Year's Day, Martin Luther King Day, Presidents Day, Good Friday, Memorial Day, Juneteenth, Independence Day, Labor Day, Thanksgiving Day, Christmas Day, New Year's Eve after 2:00PM, and Christmas Eve after 2:00PM.

Hourly Rates:

Regular Hourly Rate: \$31.75 per man hour, sampler/technician
\$43.50 per man hour, inspector

Overtime Hourly Rate: Will be billed at one and a half time the normal hourly rate and will be assessed in ¼ hour increments.

Stand-by Hourly Rate: Delays not caused by the agency will be billed at the applicable rate per man hour and will be assessed in ¼ hour increments.



Travel Hourly Rate: Billed at the applicable rate per man_hour, and assessed in ¼ hour increments. Prorated when possible. (Plus mileage).

Grain Inspection Inc. reserves the right to determine the number of personnel required to properly provide the service requested.

Minimum Call Out Time: Two hour minimum, per person, to be billed at the applicable hourly rate and prorated when possible.

Mileage: Mileage will be assessed at a rate of less than or equal to the IRS standard mileage rate and will be prorated when possible. Mileage rate is subject to change when the IRS rate does.

Finance Charge: 1 ½% per month after 30 days from statement date.

Official Commercial Inspection Services are offered and will be negotiated on a case-by-case basis from our officially approved fee schedule.

Scale Facility and D/T Sampler Inspections: Scales intended for official weighing and Mechanical Samplers intended for official sampling must be reviewed and approved prior to use. We can help with this process and the applicant will be billed at the applicable hourly rate.

Extended Load Time Fee: On-Site minimum of five cars per hour average for the train. Amounts less than five cars per hour will be billed at the current rate.

Per Diem: \$10.50 after 8 hours and \$21.00 after 12 hours per person.

Service requests not covered by this fee schedule will be performed at the appropriate hourly rate, plus travel time and mileage.

Special sample handling and shipping will be charged the actual cost and sampler travel time plus mileage as applicable.

Credit Card Fee – Direct pass through of credit card charge from credit card processor, if credit card is used.

FGIS Administrative Tonnage Fees - In addition to all other applicable fees, FGIS administrative tonnage fees for export grain shipments inspected and/or weighed, excluding land carrier shipments to Canada and Mexico, will be assessed at the current per metric ton rate identified in FGIS Directive 9180.74 Service Fees and Billing Codes, Attachment 1. Invoices will identify assessed administrative tonnage fees as separate line items per applicable carrier/unit type.

Invoices will identify assessed supervision fees as separate line items per applicable carrier/unit type.
