



# AMA FEE SCHEDULE

**EFFECTIVE DATE:** January 2nd, 2025. This revised fee schedule supersedes all other fee schedules issued by this agency. “Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current fee schedule.”

**OFFICE HOURS:** 8:00 a.m. to 4:00 p.m. Monday through Friday (excluding Holidays).

**BILLING METHOD:** Hourly rates are assessed in quarter-hour increments per person. Overtime and Sunday/Holiday rates are assessed in addition to unit fees. Holidays include New Year’s Day, Memorial Day, July 4<sup>th</sup>, Labor Day, Thanksgiving, Christmas Eve Day after 12 noon, Christmas Day, and New Year’s Eve Day after 12 noon. If holiday falls on a Saturday, then the holiday will be observed on Friday. If holiday falls on a Sunday, then the holiday will be observed on Monday.

**Standby and Travel Time:** are assessed at the application rates shown above.

**On-site Inspection:** the applicable hourly rate per person, plus the unit fee.

**Mileage Rate:** The IRS standard rate for actual miles traveled, prorated where possible.

**Lodging:** Actual expenses are assessed per person when overnight stay is necessary.

**On-site Mycotoxin tester:** Regular hourly rate \$30, Overtime hourly rate \$45, Sunday/holiday hourly rate \$60

**Cancellations:** Service requests that are cancelled within 12 hours of scheduled departure time will be billed 3 hours per person at the applicable hourly rate.

The assessed fees must exclude travel, mailing expenses, and state and local taxes. Invoices will identify assessed commodity cooperative service agreement fees as separate line items.
