Other topics will remain on work plan. Members appreciated the stakeholder feedback on Seeds and there is a lot of information to digest before determining next steps.

 - For the Seed topic, members discussed options but are not sure yet what aspect of expertise is needed.
 - For Residue Testing, leads will plan to meet with a laboratory representative and update the subcommittee.
 - Members had previously discussed if a NIFA representative would be helpful to talk to. However, it may be more relevant to the Research Priorities work agenda topic which is outside of this subcommittee.

 - Residue Testing and Risk-Based Certification topics have some cross-over so the leads will work together and coordinate as appropriate. Residue Testing will have a proposal for guidance, and a separate discussion document on regulatory updates (tightly scoped).
 - Consistency in Organic Seed Usage: Members discussed potential next steps and the need for additional information gathering to inform those steps before proceeding to a discussion document.
 - Organic Food System Capacity and Constraints – Members discussed if they want to pursue this topic that was previously put on hold. A member shared information about work that has been accomplished outside of the subcommittee that has essentially satisfied the scope of the original work agenda request. Members discussed if other issues should be considered for a new work agenda topic. The group decided to wait until new members are onboarded to revisit the discussion.

- **Risk-based Certification discussion document (KS)**. The lead summarized the draft document and outstanding issues. She asked for feedback and will incorporate suggestions for the next iteration. The lead author and CACS Chair have a meeting scheduled next week with the NOP Accreditation Division Director, Robert Yang, to discuss risk-based certification since Strengthening Organic Enforcement (SOE) was implemented. The CACS wants to ensure they aren't duplicating work or trying to solve a problem that doesn't exist. The lead confirmed that the ACA best practices documents, cited in the discussion document, are not publicly available to commenters, and will ask the ACA if it's possible to attach them as an appendix. The lead will make edits and recirculate the draft document for the next call.

- **June 25, 2024** notes were accepted as written.
- **C & E meeting schedule - date confirmation.** The CACS and members of the NOP Compliance and Enforcement (C & E) Division are planning to meet to talk about residue testing, so as the CACS works on its document they aren't overlapping or reproducing work that has already been done. The CACS Chair will confirm the dates once it's finalized.
- **Organic Food System Capacity and Constraints (ADB/NPP).** The lead summarized the lingering issues regarding the proposal and the group discussed how to move forward. Given the effort and money that the NOP has invested in TOPP, The CACS feels it's important to identify any barriers that may exist. The leads will circulate the draft proposal for discussion on July 9 call.
- **Consistency in Organic Seed Use (AJ/CD).** The leads summarized the history and context of previous NOSB recommendations. The main premise for the work was the need for continuous improvement on commercial availability. **The CACS is proposing to build on previous NOSB work, and will include the previous documents so they can collect feedback from stakeholders.** To that end, the lead mapped out questions for stakeholders to inform the Board's work. A member noted new EU regulations setting a target date of 2027 for organic seed use. The EU has also set up an expert panel. The group discussed possible barriers and concerns with using the EU model, and several members suggested modifications such as reframing the document to focus on the US and not the EU. The group also discussed the set up and maintenance of a seed database, which is better supported by the private sector and not the Federal Government. The CACS will discuss this again on August 6.
- **Risk-based Certification (KS).** The lead summarized the draft discussion document, highlighting current resources, issues, and potential gaps. She also mentioned setting up a meeting with Robert Yang of the NOP Accreditation Division, to talk more about this.

Discussion

- **June 4, 2024** notes were approved as written.
- **Risk-Based Certification discussion (KS).** The NOP approved this work agenda item on June 20, and also mentioned that Robert Yang, the Director of the Accreditation Division would be a good resource as they work on risk assessment. The CACS would like to extend an invitation to Robert Yang to join a future call. Members are interested in hearing about the result of NOP's desk audit of certifier policies for implementing Strengthening Organic Enforcement (SOE) risk assessment requirements. There isn't a standalone document in the Handbook pertaining to this, but it is incorporated into various areas, such as a course in the OILC (Learning Center Course: NOP-230 Risk-Based Oversight). The CACS views risk assessment as a longer-term project. The group discussed the outcome of this project, specifically whether it would be incorporated into the NOP handbook guidance documents or implemented in some other way, and what the timeline would be.
- **Consistency in Organic Seed Use Discussion (AJ/CD).** The NOP approved the addition of this work agenda item on June 20. The CACS plans to write a draft incorporating/referencing the two outstanding NOSB recommendations from 2018 and 2019 to seek public comment at the Fall meeting. The group discussed the timeline for adding guidance documents to the handbook, which depends on when the final recommendations are complete.
- **Review schedule.** The group reviewed the discussion schedule for the next few calls.
- **Residue testing framework overview (ADB/NPP/NL/KH).** NL summarized the work plan for this project. The project has two components: 1) updating Handbook documents on residue testing, and 2) updating the organic regulations for residue testing. There are four guidance documents in the NOP Handbook that could be updated. Examples of some proposed changes: updates to sampling procedures; lab selection criteria; and the prohibited pesticides list. The group also discussed hosting NOP staff from the Compliance and Enforcement Division at a future call, to present ongoing work on residue testing. This will help inform the CACS as to where they need to focus so they aren't duplicating work, and will inform their decision about seeking research help from the NOP's Food Technologist. In addition to guidance updates the CACS is also considering a separate piece that could lead to rulemaking, related to the frequency of residue testing and/or the thresholds for exclusion from organic sale.

Discussion

- **May 14, 2024** notes were accepted with minor modifications.
- **Reviewed the overall schedule.** The CACS schedule allows for multiple conversations of each topic before the deadline to submit proposals.
- **Organic and Climate-Smart Agriculture: Climate Induced Farming Risk and Crop Insurance (ADB).** The lead gave a brief summary of comments from the Spring NOSB meeting, and the group discussed the plans for the document for the Fall meeting. A member suggested the addition of examples that represent a diversity of crop types and don't solely focus on grains.
- **Oversight improvements to deter fraud: Residue Testing for a Global Supply Chain (ADB/NPP/NL/KH).** The co-leads met to discuss the road map for the future proposals and discussion documents, and will likely split the project into two paths: 1) work on updating the guidance documents for residue testing, including the existing documents in the NOP Handbook and possibly a new guidance document with risk factors/decision tree for residue sampling, and 2) work on updating the NOP regulations for residue testing, including the frequency of residue testing and the EPA tolerance threshold when products are excluded from organic sale.
- **Organic Food System Capacity and Constraints (ADB/NPP).** The CACS didn't receive much stakeholder feedback from the Spring meeting. The Subcommittee discussed market data, indicating that the data is lacking - mainly on the demand side. A member noted that USDA does not publish data for demand-side, and that information is supplied by industry. The USDA's Market News Office does collect some data. CACS is seeking ways to initiate the conversation with industry and will include a targeted set of questions asking about an organic version of the demand reports.
- **Potential new work agenda items.**
 - Risk based certification (KS). The CACS reviewed a framework for assessing risk, and discussed whether to develop a work agenda item. The goal would be to streamline work for certifiers and operations, and make it more consistent. The group will write up a draft work agenda request that could lead to a discussion document for the Fall 2024 meeting, with issues/problems/possible outcomes to gauge interest.
 - Organic seed use (AJ/CD). The CACS discussed a work agenda item on Organic seed, as it appears the percentage of use in the US is low. The lead noted that EU regulations recently changed to require transition to 100% organic seed by 2036. Given that the commercial availability clause has been around for a long time and doesn't seem to be working well, the

CACS would like to write a proposal to offer solutions about use and requirements. Members offered feedback and posed questions, such as looking at seed from a handling perspective rather than from a grower’s perspective. Who would benefit and who might not? What are the end goals? NOP noted that it is also talking about this topic, and asked how the CACS could build on the previous NOSB recommendations (from 2018 and 2019). The CACS will rescope the request to include feedback from today’s call, and will discuss this again on the next call, with the goal of submitting it to the Exec Team for approval as soon as possible.

Discussion

- **December 12, 2023** notes were accepted as written.
- **Guest Speaker** - Kate Mendenhall (OFA): Equity and Racial Justice in Organic Transition; Ryann Monteiro (OFA). Kate and Ryann provided an update about the Transition to Organic Partnership Program (TOPP) program, and what the central tenants are for racial diversity, identifying systemic racism, and barriers to organic transition & certification, acknowledging geographic barriers, and a country that is culturally and regionally diverse. Ryann added that racial equity and BIPOC (black, indigenous, and other people of color) are not the same. The 2022 Organic Farmers Association (OFA) report contains much of the information presented today, and the 2023 report will be available soon. <https://organicfarmersassociation.org/dei/>
Both Kate and Ryann fielded questions from the CACS members, and the group discussed topics such as how to improve the process for certification, and how to expand the tent while still maintaining the integrity of the organic certificate. A member asked about NOSB's role, given that the OFPA directs the NOSB to engage with certified operations and operators, and they aren't really positioned to solve issues with barriers to certification. A member suggested that giving voice to the issues could be helpful. Another member added that the organic industry and advocates, who are in a position to influence legislation might be in a stronger position. The group also discussed availability of resources, looking at grower groups as a potential model for resource sharing, market risk, building institutional knowledge and expertise in technical support, and international models, such as Denmark, who uses an integrated model for organic agriculture.
- **Improving Support for Organic Transition (AJ)**. The lead circulated a draft in December, and will integrate some of the information from today's discussion into the next iteration, which will be discussed again in February.
- **Climate Induced Farming Risk and Crop Insurance (CD)**. Deferred to next call.
- **Residue Testing for a Global Supply Chain (ADB/NPP/NL/KH)**. Deferred to next call.

- **Organic Food System Capacity and Constraints (formerly Market Development) (CD) updated work agenda request.** The CACS Chair submitted the work agenda request to the NOP and is awaiting a response about whether it is approved.
