- Human Capital Management (All). The group discussed the request from the NOP to engage the community in a conversation about human capital management. At this time the NOP is not looking for a recommendation for a rule, guidance, or instruction, but is seeking to start a conversation to solicit feedback from stakeholders. The hope is to improve and strengthen inspector qualifications, and not to eliminate staff. Members discussed inspector training, which is often comprehensive for certifier staff, but less so for contract or independent inspectors. These non-staff inspectors don't necessarily have access to mentors or a formal framework or support network, and that is an area the CACS would like to address. Members discussed comments they have received from their stakeholder communities regarding auditors, inspections, and compensation. Two members drew distinctions between industry and food safety inspections versus organic inspections.

The CACS will post a brief summary for the Fall NOSB meeting pointing to the NOP memo to solicit feedback. The CACS Chair volunteered to lead this project and to synthesize the comments for the Fall meeting.

- **Strengthening Organic Enforcement Rule (SOE).** The CACS discussed the SOE rule, which was recently published in the Federal Register. The comment docket is open and closes October 5, 2020.
- Other items. The USDA announced changes to the organic cost share program which supports the community by paying a portion of certification costs. CACS members relayed feedback from stakeholders indicating that they were surprised, frustrated, and alarmed that the subsidy was reduced from 75% to 50% per scope.

- Human Capital draft request. The NOP drafted a document for the CACS on a project to lay out a
 framework/strategic plan around human capital management, focusing specifically on organic
 inspectors and reviewers. The NOP is seeking feedback from the CACS/NOSB about what this project
 could entail. The group discussed a gap analysis, pipeline development, and retention of reviewers and
 inspectors. A member mentioned that there could be a role for academic institutions (specifically
 agricultural colleges) to provide online courses. The NOP noted that there will be a new course in the
 Organic Integrity Learning Center developed by a university, which could be used as a case study for this.
 The CACS also asked about ways to increase diversity in the inspector community. Next steps: the CACS
 will provide feedback to the NOP (by July 23), the NOP will continue to work on the document, and the
 CACS may develop a discussion document for the Fall meeting to solicit public comment.
- Strengthening Organic Enforcement (SOE) Proposed Rule. The NOP held a webinar last week to announce the impending proposed rule on SOE. More than 900 members of the community attended. The CACS Chair summarized the path to the rule which was the culmination of 10+ years of work by the NOP, the NOSB, and the organic community. The draft rule is posted on the AMS website along with several document resources, including a side-by-side comparison of the original regulation and the proposed changes. Once the rule is published in Regulations.gov the public will have 60 days to comment.

Other Items.

- Members shared experiences about virtual and hybrid inspections. The community continues to perform inspections and audits virtually or using a hybrid model to limit in-person visits to promote safety. Some organizations are restricting in-person inspections altogether and prohibiting air travel. Other practices include employment of local inspectors, which helps minimize travel. A member noted that she has an inspection scheduled and it will be conducted in person, but outside and physically distanced.

- Inspector human capital. NOP is developing a work agenda item for the CACS and anticipates that it will send a memo to the Board prior to the Fall meeting. Since there are only two calls between now and the proposal deadline it is not likely the CACS will have time to develop a document for the Fall meeting.
- Reduced-contact inspections (ALL). Members shared their experiences conducting inspections and audits while continuing to limit contact and social distance. Several members indicated using a hybrid approach part virtual and part field-based. The CACS Chair noted that WSDA has been doing limited contact inspections for about 1.5 2 months and things are going well, and they are receiving positive feedback. In the next phase they will be prioritizing inspections, and will continue to inspect new sites while distancing appropriately.
 - A member shared that he began the season doing 100% virtual inspections but has moved to a hybrid approach that includes visiting a facility, riding around in separate vehicles, and then stopping and talking at a distance. Another member also noted a hybrid approach for Crop inspections. For processers, audits are virtual for now, and onsite physical inspections will be scheduled at a later date. She also shared that Handling operations are more challenging than other inspections, and they are working on ways to move forward.

The group praised the best practices that were developed by the inspector community working group. These best practices also included the development of a registry of local inspectors so inspections can continue while minimizing travel. The CACS Chair noted that it's working well so far, and the most difficult challenge is orienting inspectors to different forms and processes for each certifier. He also noted that there are some underserved regions that have a lack of inspectors.

- November 12 notes were accepted as is.
- Strengthening organic enforcement (SOE) rule update. Currently the proposed rule is under review at the Office of Management and Budget (OMB), and CACS is awaiting its publication before moving forward.
- Other items:
 - The CACS Chair provided a summary from the quarterly IOIA inspector-certifier call, noting that the work of these two communities intersects often.
 - A member informed the CACS that once she rotates off the Board later this month she
 will be working with a certifier on energy infrastructure. She also indicated that she was
 recruited as an expert witness for a lawsuit for farmers who have a pipeline proposed
 on their land.
 - A member offered some thoughts about Strengthening Organic Enforcement (SOE) and enforcement in general. With regard to SOE she noted that addressing exclusions and exemptions in organic will create a more transparent supply chain and are considered significant steps. She also emphasized the need for the CACS and NOSB to continue to push for higher standards when it comes to enforcement and improvement, even in small increments.
 - The CACS Chair shared with the group that the NOP sent a notice to certifiers announcing a call for proposals/lessons for the Organic integrity Learning Center. Of particular note is the inclusion of "Addressing Energy Infrastructure Projects" Special Standards Topics section. The CACS Chair will discuss the use of the Organic Integrity Learning Center as a platform at the upcoming certifier training in San Antonio, TX.
 - The group also briefly discussed inspectors, and their designation as either an employee or contractor.
