Dear Secretary Vilsack,

As USDA certified organic dairy farmers from 24 states across the country, we urge the Department to ensure the proposal calling for an Organic Exemption<sup>1</sup> is included in any Federal Milk Marketing Order (FMMO) national hearing, referred to in the USDA Agricultural Marketing Service—Dairy Program's Action Plan<sup>2</sup> published on June 1, 2023.

As a collection of organic farmers who market organic milk through cooperatives, as direct shippers to dairy buyers, or under our own brands, we feel the FMMO system has failed to recognize the unique position of organic milk and has not provided similar services enjoyed by other dairy farmers.

Certified organic milk is a distinct commodity produced in accordance with federal law and subsequent National Organic Program regulations in 7 C.F.R. § 205. Not only is this affirmed in the authorizing law and standards, but organic dairy, along with other organic crops, fruits, and livestock are allowed an exemption from 22 national promotion and research board assessments. This allowance, codified into law as part of Section 10004 of the Agricultural Act of 2014 (2014 Farm Bill³), further acknowledges the unique market needs of organic agricultural products.

Examination of the dynamics of the organic milk market further sustains our position that organic milk does not appropriately fit the tenets or purpose of the Federal Orders, and the Orders should be amended to reflect that experience.

Organic milk is not substitutable with other milk pooled on the orders, and more importantly, its pricing has historically exceeded regulated minimum prices and is detached from classified pricing.

Yet the reality is the Federal Order rules and requirements impact our farm gate milk price by burdening us and our organic dairy buyers with pool payments that go overwhelmingly to non-organic producers.

The proposal to exempt organic milk from pooling requirements is developed in a manner that maintains transparency, safeguards farmers, and demonstrates accountability. The Organic Exemption would:

- Only apply to USDA Certified Organic milk **that is priced above the Class I minimum price.** Using Class I as the standard ensures that organic producers are paid at least the highest conventional price for that Federal Order—a backstop benefit for farmers.
- Ensures that handlers of organic milk remain subject to existing reporting requirements, enforcement mechanisms, and administrative fees in the FMMO system. The Market Administrators would still review records to verify the application of any Organic Exemption.

If adopted, an Organic Exemption would have only a small impact on the uniform prices of the 11 Federal Orders and little, if any, impact on consumers, but the exemption would matter greatly to organic dairy farmers like us.

We urge you to move forward with a national Federal Orders hearing that includes the Organic Exemption proposal. The hearing needs to examine the untenable position of organic dairy in the FMMO system. The growth of organic dairy as a specialized product from the farm and the impact the current Order regulations have on our organic milk pay price make this a necessary request.

We appreciate USDA's hard work to support organic dairy farmers facing challenging economic conditions and look forward to bringing our additional analysis and witnessed experiences to any forthcoming FMMO hearing.
