Discussion

- **April 1, 2025 notes** were accepted as written.
- **Prep for Spring NOSB meeting.**
 - The NOSB Chair circulated a list of key dates for the next couple of weeks. The turnaround time prior to the Spring meeting is tight but they will do the best they can. Members were all invited to attend the Executive call later this afternoon.
 - The Chair described the process for the oral comment webinars and encouraged folks to attend the practice webinars, on which they will discuss the approach for the Spring meeting, as well as the process for delivering sunset reviews this Spring.
 - Questions for NOP. One member suggested an update on enforcement. The goal is to get the questions to the NOSB Chair by April 18 so she can pass them along to the NOP.
 - Public comment summaries. The deadline for written comments is April 28, which is the first day of the meeting. The board has reached out to stakeholders asking them to submit early if possible.
- Compostables (NL) - TR sufficiency is due May 27. The CS will discuss and determine sufficiency via email before Thursday April 17, so they can get any feedback to the TR writer before the end of the month. The lead noted that the TR was well written and comprehensive, and will gather feedback from other members before deeming it sufficient. A member shared some thoughts about the TR, which he shared with the lead, in case they do send the TR back for some additional questions. He noted three areas he would like more information about, including produce stickers.
- **Additional items.**
 - Members talked about the pear ester petition, and will continue that conversation at the NOSB meeting so it is on the record.
 - The CS canceled its May 6 call.

Discussion

- **January 21, 2025 notes** were accepted as written.
- **Compost (NL) - overview/update.** The lead provided a history of this topic for the benefit of members. This project is the culmination of two items: The first, a petition that came to the NOP, which the NOP then sent to the Board to work on; and secondly, a Board request to update and refresh the compost rules, given that they hadn't been updated in more than 20 years. NOSB passed a final recommendation at the Fall 2024 meeting that addresses part of the work agenda item. The Crops Subcommittee voted on another compost proposal during the last call that clarified that synthetic compost feedstocks must be added to the National List. The document is now considered final and will be submitted for the Spring meeting.
- **2027 Sunsets: Sucrose octanoate esters (FQ). TR sufficiency.** The lead summarized the TR and asked a question of the group about the lack of registered products. The group would like to determine if there are any products in use, and will discuss that on the next call when they complete the review for the spring meeting. The TR was found sufficient, and the Chair will let the NOP know.
- **Synthetic Compost Feedstocks discussion document (NL).** This discussion document explores synthetic compostable polymers, and includes discussion of residues and unavoidable residual environmental contamination (UREC). Members shared various ideas and thoughts about the impetus for this project and the path forward, and reviewed the questions to stakeholders. The CS moved to a vote and will forward to the full board for the Spring meeting.

Discussion

- **December 17, 2024** were accepted with minor corrections.
- **2027 Sunsets: Sodium silicate (MJ).** The lead summarized the TR and review for sodium silicate. The TR was found to be comprehensive and sufficient. The group discussed the uses of sodium silicate and suggested minor edits. The lead will incorporate the suggestions and submit the final document for the Spring meeting. The CS Chair will convey to the NOP that the TR was found sufficient.
- **2027 Sunsets: Soap-based algicide/demossers (ADB).** The lead summarized the review for soap-based algicide, and noted that a previous Board voted to remove it. Based on public comment, indicating that this substance was still in use, it was not removed from the National List. The CS will submit the review for the Spring 2025 meeting.
- **2027 Sunsets: Soaps, insecticidal (ADB).** The lead summarized the review for insecticidal soaps, and there were no follow up questions. At its last review the Board voted to renew its listing. The CS will submit the review for the Spring meeting.
- **2027 Sunsets: Vitamin D3 (ADB).** The lead summarized the review for vitamin D3, highlighting the environmental issues, which she noted are minimal and less risky than other rodenticides. Members had no follow up questions, and the CS will submit the review for the Spring meeting.
- **2027 Sunsets: EPA List 4 Inerts (BC/NL).** The lead reminded folks that the NOP is considering a Fall 2024 recommendation from the Board about reviewing inerts, and while that is underway, they are faced with reviewing the current listing. The lead feels the best path forward would be to renew the listing as is, while rulemaking progresses. Members agreed with this approach and the CS will submit the document for the Spring meeting.
- **Research Priorities (BC).** The group discussed the suggested list of priorities for Crops, which was partly developed based on public comment. Possible research topics include organic seed, plastic use/PFAS, and fluorine. A member added two other topics: compost and the fate of contaminants in compost; and "fitness cost" of contamination on the microbial/fungal communities cultivated in compost making.
