Dear Mr. English:

On September 29, 2015, the Organic Trade Association (OTA) and its members submitted a formal request to the U.S. Department of Agriculture (USDA) for a hearing to amend the ten existing Federal milk marketing orders (FMMOs). The proposed amendment would provide a credit to organic fluid milk handlers against their monthly FMMO pool obligations, dependent upon the price paid to dairy farmers for organic milk. On May 10, 2016, USDA received your supplemental submission in support of the initial formal hearing request. USDA is continuing to review the market concerns raised and the information provided in your proposal, along with the supplemental information from your letter dated May 10, 2016.

In addition, USDA received your June 30, 2016, request for data and additional information from AMS, NASS and ERS. The request included:

- Updated data on previously submitted requests: The requested data is enclosed.
- List of Partially Regulated Distributing Plants (PRDPs): The requested data was provided on September 1, 2016.
- *PRDP volume and utilization data:* The data is unavailable or restricted due to data confidentiality concerns.
- *Milk sold to or on military facilities:* The data is not available because such route dispositions are not tracked separately.
- PRDP financial impact on producer settlement funds and a breakdown of organic producer receipts: As discussed, further clarification regarding this request is needed.

At this time, we consider your data request, dated June 30, 2016, complete. We will be happy to work with you on the remaining data request once we receive further clarification. We appreciate the opportunity to assist you with various information and data needs related to your proposal.
