### JOINT MOTION REQUESTING EXTENSION OF DEADLINE FOR SUBMISSION OF PROPOSED CORRECTIONS TO TRANSCRIPT

Proponents of Proposals 1 and 2, California Dairies Inc., Dairy Farmers of America, Inc., and Land O'Lakes, Inc., and the Dairy Institute of California jointly request a 10 day extension of the deadline for submission of proposed corrections to the transcript of proceedings of the hearing held September 22, 2015 through November 18, 2015.

As of Noon on December 31, 2015, transcripts through the date of November 11 -- 35 hearing days – have been posted to the USDA website. Five more days (volumes) are needed for a complete record. The January 15 date for submission of corrections to the transcript was expressly premised upon all transcripts being posted on the USDA website by December 31, 2015. The court reporter has indicated to counsel that she expects to have all transcripts filed by January 10, 2016.

We further suggest that the date for transcript corrections from other parties by adjusted accordingly. No change in the dates for filing of briefs is requested.
