Livestock Mandatory Reporting Wholesale Pork

LMR Staff and Data

- Pork Team
 - Des Moines, IA Office
 - 3 Market Reporters
 - Analyze 8,000-10,000 records per day
 - Generate, edit, and publish 4 daily LMR reports and 8 weekly LMR reports

LMR Staff and Data

LMR Coverage

- 87% of total pork sales captured
- Average of 13.8 million pounds reported daily in 2015
- 15% of pork sales are negotiated

LMR Wholesale Pork Criteria

- Anyone slaughtering more than 100,000 head of swine (barrows and gilts) on average the preceding 5 calendar years
- Anyone slaughtering more than 200,000 head of sows and/or boars on average the preceding 5 calendar years
- 24 packers or 50 plants reporting

LMR Wholesale Pork Criteria

- Regulations allow packers to stop reporting up to one half hour ahead of specified reporting time
- Morning Report: all sales made for 2:00 PM CST deadline the prior business day up until 10:00 AM CST
- Afternoon Report: all sales made from the morning submission until the 2:00 PM CST submission deadline

LMR Wholesale Pork Criteria

- Sow and Boar product only submitted once a day by 2:00 PM CST

Wholesale Pork – Form LPS-89

Notable Criteria:

- Destination – domestic, overseas, NAFTA
- Sales Code Type – Negotiated, Forward, Formula
- Delivery Period Code
- Refrigeration – 0-6 days fresh combos, 7 or more fresh combos, 0-10 days fresh boxed, 11 or more fresh boxed, or frozen

- Class Code – barrows/gilts, sows, boars, mixed
- Product Code
- Total Product Weight – pounds
- FOB Plant Price - \$/cwt
- FOB Omaha Price - \$/cwt

LMR Wholesale Pork Data

- Includes all wholesale pork fresh and frozen primals, subprimals, cuts fabricated from subprimals, pork trimmings, pork for processing and designated variety meats
- Excludes portion control cuts, flavored cuts beyond normal added ingredients, smoked, and cured cuts

LMR Wholesale Pork Data

- Includes reported variety meats such as neck bones, tails, skins, feet, and hocks
- Includes reported enhanced cuts with ingredients limited to water, salt, sodium phosphate, antimicrobials, or any combination of these items

Confidentiality and Data Review

- For all Wholesale Pork Reports 3/70/20 is applied
- Reporters review submitted files at submission deadlines. Use checklists to ensure all plants have reported and then import data files.

Data Review

- For wholesale pork there is an exclusion policy to automatically exclude all lots containing less than 2,000 pounds and price ranges with the same low and high price from the reported lines.
- However all trading, whether excluded or included, is used in the pork cutout calculations.

Data Review

- Reporters handle between 8,000 and 10,000 records per day and have technical processes in place that flag any data falling outside preset parameters. This data is then confirmed by reporters through direct correspondence with buyers and sellers.
