Discussion

- **February 11, 2025 notes** were accepted as written.
- **Resource needs for PPM updates.** The group discussed several potential topics for PPM updates, and scheduled discussion dates with the goal of having a proposal for the Fall 2025 meeting.
 - Annotation Change procedure (ADB). Scheduled for April 8.
 - TR/TAP procedures (CD). The goal of the update is to clarify the standard process for determining the need for a TR, or not, and to make sure the process is transparent.
 - Sharepoint Governance & AI policy (NL). The Sharepoint guidance is straightforward, and the PDS discussed how they will actually use the resource. As for the use of AI, a member suggested some useful language provided to students: The use of AI is discouraged, but IF one chooses to use it, one must cite what and how it was used. She added that given the known detrimental environmental effects of data centers, AI seems incompatible with Organic.
- **Collecting stakeholder input on Administration's priorities.** The PDS feels it would be more constructive to stay the course with regard to its work, stay in listening mode, and focus on what is mandated in OFPA. A member added that there are other channels that stakeholders can use if they wish to provide general feedback to the USDA. A member reiterated that it would be better to wait, and not get ahead of themselves, and that there is plenty of work in the meantime.

Discussion

- **January 14, 2025 notes** were approved as written.
- **PPM updates (All) - sunset review efficiency discussion document.** The group reviewed the draft document, which proposes a change to improve efficiency at the NOSB meetings. At the Fall 2024 meeting, the NOSB piloted a procedure to see if it was feasible, and while it created some efficiency, and saved some time, voting on each substance still took time. The process involved giving a brief summary of the sunset substance if the following criteria were met: a substance was non-controversial; and members were unanimous that it would be relisted.

This discussion document proposes a new iteration of the process, and includes a timeline to trial other iterations to see what works best. Members discussed a formalized list for “consent” voting, transparency, and mechanics and structure of the process. Members agreed that it would be better to test it at the spring meeting, after public comments, so it’s clearer which substances may end up on the consent agenda. To allow for maximum transparency, the PDS will submit a discussion document for the Spring NOSB meeting. The lead will modify the current draft to incorporate the topics discussed today, and the group will vote via email by the Thursday deadline. The PDS will discuss this more during its next call.
