- 3. Documentation may be requested to verify shipments.
- 4. Reports shall be submitted to the Raisin Administrative Committee (RAC) on or before the seventh day of each month by 10:00 am, covering the shipments for the preceding month.
- 5. Consult RAC staff on any points not clear to you.

This report is required by law (7 U.S.C. 608d, 7 CFR 989.173, CFR 989.173(c)(1)(iv)). Failure to report can result in a fine of \$3,501 for each such violation, and each day during which such violation continues shall be deemed a separate violation.
